The Houghton County Board of Commissioners held a Regular Meeting / Public Hearing on Tuesday, June 14, 2011 at 5:00 p.m. in the 5<sup>th</sup> Floor Conference Room of the Courthouse, City of Houghton.

After the Pledge of Allegiance, the following commissioners responded to roll call: Edward Jenich, District 1; Dennis Barrette, District 2; Anton Pintar, District 3; Scott Ala, District 4; and Timothy Palosaari, District 5.

A motion was made by Commissioner Barrette and seconded by Commissioner Pintar to approve the minutes of the May 10, Regular Meeting and the May 26, Special Meeting as presented. The motion carried by a voice vote. Ayes 5, Nays 0.
