

**HOUGHTON COUNTY BOARD OF COMMISSIONERS  
SPECIAL MEETING  
JUNE 8, 2018**

The Houghton County Board of Commissioners held a Special meeting on Friday, June 8, 2018, in the 5<sup>th</sup> Floor Conference Room of the Courthouse, City of Houghton.

Call to Order:

The meeting was called to order by Chairman Albert Koskela at 12:08 p.m.

Pledge of Allegiance:

The Pledge of Allegiance was led by Chairman Koskela.

Roll call:

The following commissioners responded to roll call:

Tom Tikkanen, District 1; Albert Koskela, District 2; Anton Pintar, District 3 and Tim Palosaari, District 5.

Absent: Scott Ala, District 4.

Approval of Agenda/Additions:

The Board discussed changing the June Board meeting date due to lack of Commissioners being able to attend on June 12, 2018.

A Motion was made by Commissioner Tikkanen, seconded by Commissioner Palosaari to approve the Agenda with the one addition to F-#2 for rescheduling the June Board of Commissioners meeting.
