MEMO

Houghton County Commissioners Re: Sanctuary County Resolution March 4, 2020

I have been asked to provide an opinion regarding the legality of the Sanctuary County Resolution. This issue is currently one being addressed by many counties throughout the state of Michigan, and each county is treating the issue in a slightly different manner. The bottom line regarding the resolution in any form, is that a decision to pass a resolution of this nature is more a political issue than a legal issue. However, below I will provide some law for you to consider in making your decision.

First, all Commissioners took an oath to uphold the Constitution of the United States and the Michigan Constitution. This oath, in and of itself, could show the position of the Board, if that is how you would choose to approach the issue.

Second, MCL 46.11 (see attached) sets out the powers of the county board of commissioners. Section (j) states in part that the county board can pass ordinances relating to county affairs, but the ordinances cannot contravene the general laws of the state. While I understand the proposed document is a resolution, and not an ordinance, I think it is still important to note this distinction because it sets forth a legal limitation in powers. Further, many requests included in the resolution are not included in the powers given in the statute. That idea should be considered in deciding what portions of the resolution, if any, to pass.

Third, MCL 123.1102 (see attached) states that:

"[a] local unit of government shall not impose special taxation on, enact or enforce any ordinance or regulation pertaining to, or regulate in any manner the ownership, registration, purchase, sale, transfer, transportation, or possession of pistols, other firearms, or pneumatic guns, ammunition for pistols or other firearms, or components of pistols or other firearms, except as otherwise provided by federal law or a law of this state."

Based on this language, a county board cannot make an ordinance or regulation regarding pistols, firearms, or other guns, unless the ordinance or regulation is already provided for in federal or state law. Thus, many requests in the resolution could potentially go against the above statute and would have no legal backing, unless the state or federal government passed their own laws. The Legislature could choose to pass laws regarding the issues in the proposed resolution, which been brought up at a state level. However, the remedy if constitutionality was brought into question would be for the judiciary to rule on the issue.

Last, as has been made clear in other resolutions throughout the state, the Board does not have the authority to direct the activities of the Sheriff or Prosecuting Attorney.

To address legal repercussions, considering the recent nature of many of these resolutions, there seems to be no way to truly gauge future legal repercussions. It should be noted, however, that there are currently issues between the federal government and immigration sanctuary cities, and there is no way to know what impact, if any, a designation of second amendment sanctuary would have federally in the future.

In conclusion, I have reviewed resolutions that have been passed by county boards throughout the state, some choosing to be sanctuary counties, some choosing to affirm their oath, and some finding a position in between. I have provided the law I believe could be relevant and some issues for consideration, but the decision on what to pass is not one based solely on the law and, therefore, cannot be based on a legal recommendation. If there are any other specific questions that have been raised by this memo, or anything else you would like me to review, please let me know.

RESOLUTION OF HOUGHTON COUNTY BOARD OF COMMISSIONERS

WHEREAS, the Second Amendment of the United States Constitution affirms, "[a] well regulated Militia, being necessary to the security of a free state, the right of the people to keep and bear Arms, shall not be infringed," and

WHEREAS, the United States Supreme Court in *District of Columbia v. Heller*, 554 U.S. 570 (2008), affirmed an individual's right to possess firearms, unconnected with service in a militia, for traditionally lawful purposes, including self-defense within the home, and in *McDonald v. City of Chicago*, 561 U.S. 742 (2010), affirmed that such rights are incorporated by the Due Process Clause of the Fourteenth Amendment against the states, and

WHEREAS, the United States Supreme Court in *United States v. Miller*, 307 U.S. 174 (1939), opined that firearms that are part of ordinary military equipment, or with use that could contribute to the common defense are protected by the Second Amendment, and in *Caetano v. Massachusetts*, 136 S. Ct. 1027 (2016), affirmed that the "Second Amendment extends, prima facie, to all instruments that constitute bearable arms, even those that were not in existence at the time of the founding," and

WHEREAS, Article 1, Section 6, of the Michigan Constitution affirms, "[e]very person has a right to keep and bear arms for the defense of himself and the state," and

WHEREAS, Article 1, Section 1, of the Michigan Constitution affirms, "[a]Il political power is inherent in the people. Government is instituted for their equal benefit, security and protection," and

WHEREAS, the Houghton County Board of Commissioners wishes to express its deep commitment to securing and protecting the rights of all citizens of Houghton County to keep and bear arms, and

WHEREAS, the Houghton County Board of Commissioners is concerned about, and wishes to express its opposition to, any law or current and future legislation containing language which could be interpreted as infringing the rights of the citizens of Houghton County to keep and bear arms, and

WHEREAS, the Houghton County Board of Commissioners wishes to express its intent to stand as a Sanctuary County for the right to keep and bear arms and to oppose, within the limits of the Constitution of the United States and the State of Michigan, any efforts to unconstitutionally restrict such rights, and to use such legal means at its disposal to protect the rights of the citizens of Houghton County to keep and bear arms, including through legal action, the power to appropriate public funds, and the right to petition for redress of grievances.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Houghton County Michigan:

That the Houghton Board of Commissioners hereby declares Houghton County, Michigan, as a "Second Amendment Sanctuary", and

That the Houghton Board of Commissioners hereby expresses its intent to uphold the rights of the citizens of Houghton County, Michigan, as protected by the Second Amendment to the United States Constitution and Article 1, Section 6, of the Michigan Constitution, and

That the Houghton Board of Commissioners hereby expresses its intent that county resources, including funds, not be used to infringe or restrict the rights of any citizen affirmed by the Second Amendment and Article 1, Section 6, of the Michigan Constitution, nor be used to aid any state or federal agency in infringing or restricting such rights.

Houghton County Land Bank Authority 2019 Annual Report

Board of Directors: Lisa Mattila, Chairperson; John Haeussler, Secretary; James Hainault, Treasurer; Glenn Anderson; Tom Tikkanen.

The Houghton County Land Bank Authority Board of Directors (LBA) met ten (10) times in 2019: January 28, April 30, May 31, June 11, June 28, September 12, October 1, October 20, November 18, and December 20.

The board elected to retain the 2018 officers with Director Haeussler serving as secretary and Director Hainault serving as treasurer. Directors Anderson and Hainault were reappointed by the Houghton County commissioners to three-year terms expiring December 31, 2022.

Entering 2019 the LBA had thirty (30) parcels in its inventory. Five (5) of these parcels were transferred during the year. (Table 1, Parcels 1-5.)

The Houghton County treasurer foreclosed forty-four (44) parcels in 2019. The LBA discussed many of the tax-foreclosed parcels and the majority of them were visited by one or more directors for visual inspection.

Prior to the first public tax sale auction the LBA expressed interest in obtaining four (4) of the 2019 taxforeclosed parcels. The county commissioners approved the county's purchase of the four (4) parcels from the county treasurer, and the sale of the parcels by the county to the LBA. Two (2) parcels were subsequently sold and two (2) remain in the LBA's possession. (Table 1, Parcels 6-9.)

One parcel that was sold in a previous year reverted to the LBA due to the failure of the purchaser to meet the conditions agreed to in a reverter clause. (Table 1, Parcel 10.)

The LBA received a \$50,000 Michigan Rural Community Demolition Grant from the Michigan Land Bank Fast Track Authority toward demolition of the structures, abatement of hazardous materials, and additional work related to the cleanup of the former Lakes Building Supply in Lake Linden. The LBA engaged the Keweenaw Economic Development Alliance (KEDA) to manage the project. The structures were subsequently demolished and the site was cleaned and prepped for redevelopment. An initial Request for Development Proposals was released with no proposals being received. A second Request for Development Proposals was released with one proposal being received. At the conclusion of 2019 the LBA was reviewing this proposal.

KEDA Executive Director Jeff Ratcliffe was actively involved with the LBA throughout 2019. The LBA appreciates Mr. Ratcliffe's efforts and looks forward to continued collaboration with KEDA and other local partners.

KEDA has submitted a preliminary proposal for a \$1,362,000 U.S. Housing and Urban Development Community Development Block Grant through the Michigan Economic Development Corporation and Michigan Strategic Fund. If successful, the funds will be utilized to bring three LBA properties in the Village of Calumet — 425 Fifth Street (aka the Aho Building), 451 Pine Street (formerly the Rose & Thorn), and Fifth Street/Pine Street (formerly the Sullivan Livery) — to "white box" status and clean up a fire-destroyed property at 336 7th Street that will likely end up in tax foreclosure. The LBA has pledged \$10,000 in matching funds toward the project.

The LBA initiated and approved a Release of Liability Form which must be completed and approved prior to entering LBA-owned property.

At the close of 2019 the LBA had twenty-eight (28) parcels in its inventory. (Table 2.)

WHEREAS, the County of Marquette recognizes the effects of storms, high water, and wind driven wave action that is causing severe erosion to the shorelines, infrastructure, and private property along the Great Lakes, and

WHEREAS, the conditions of the Great Lakes shorelines directly affect business and tourism in Marquette County and the State of Michigan by limiting access to beaches, boat landings, and parks along the shorelines, and loss and damaged property directly affects the local, county, and state tax base, and

WHEREAS, Marquette County, as well as other shoreline communities in the State of Michigan are desperately in need of additional resources to combat shoreline erosion and protection of natural resources.

Emergency Management and Safe Schools

WHEREAS, The Office of School Safety created under the Michigan Public Act (PA) 435 of 2018, alongside Michigan Public Act 670 of 2018, identifies the department of Michigan State Police as being the exclusive agency responsible for all Michigan schools with respect to, but not limited to education, training, reporting and building assessments pertaining to safety and security using an all- hazards approach; and

WHEREAS, the Upper Peninsula (Region 8) Public Act 390 programs, have been undertaking safe school training and safe school professional development since 2005; and

WHEREAS, current Michigan law requires Emergency Management to oversee school drills; and

WHEREAS, the appointment of school safety to the department of Michigan State police circumvents the underlying core functions of emergency management which is placing school safety programs under the umbrella of all-hazards emergency management planning; and

WHEREAS, local responders and local Public Act 390 emergency management programs are far more aware of school dynamics, as they have on-going working relationships with school staff, regularly communicate, plan, and exercise emergency action plans with said schools; and

WHEREAS, funds for a new division could be better used by redistributing to existing local emergency management Public Act 390 programs that are already providing safe school protocols in their respective jurisdictions; and

WHEREAS, the Office of School Safety should be established within the Michigan State Police department of Emergency Management and Homeland Security (MSP EMHSD) Which under the Michigan Public Act 390 of 1978 statutorily appoints the MSP EMHSD as the administrator of emergency management within Michigan and the fiduciary for the distribution of grant monies across all of Michigan's 83 counties in collaboration with local emergency managers.

NOW, THEREFORE, BE IT RESOLVED that the Michigan Emergency Management Association (MEMA) requests the Michigan Legislature amend the Office of School Safety placing it within the MSP EMHSD to coordinate the distribution of school security funds with local community response personnel and local Public Act 390 emergency managers.

BE IT FURTHER RESOLVED that copies of this resolution be forwarded to all Upper Peninsula counties, the Upper Peninsula Commission for Area Progress (UPCAP), the Michigan Townships Association, the Michigan Association of Counties, Upper Peninsula Legislators and Governor Whitmer.
